DIRECTIONS FOR USE

Use only as indicated.

For use in the home, on the farm and industrial premises. Kombat Rats and Mice Pellets can kill rats and mice after a single feed. Death of rodents will take 4-12 days. Effective against warfarin resistant rats and mice.

NORWAY AND ROOF RATS:

Place Kombat Rats and Mice Pellets in a covered bait station to prevent access by children and domestic animals.

Place 50-70 g of Kombat Rats and Mice Pellets per bait stations along the walls and active rat runs, in rat burrows and in sheltered areas where rats are known to live or feed. Bait points should be inspected and replenished every 7 days until feeding ceases.

MICE:

Place 10-20 g Kombat Rats and Mice Pellets per bait station every 2-4m along the wall or runways, in nests and in sheltered areas where mice are known to live and feed. The single feeding action of Kombat Rats and Mice Pellets is particularly effective against mice with their small appetites and sporadic feeding behaviour.

GERBIL:

Place 50-70 g Kombat Rats and Mice Pellets in protected bait stations 10 m apart or 10-20 g placed into active holes in the colony.
