#### SYMPTOMS OF POISONING

Symptoms may include nausea, vomiting, diarrhoea, abdominal cramps, headache, vertigo, ocular pain, ciliary muscle spasm, blurring or dimness of vision, miosis, or in some cases mydriasis, lacrimation, salivation, sweating, and confusion. In severe cases, there may also be involuntary defecation and urination, bradycardia, hypotension, pulmonary oedema, convulsions, coma, and death from respiratory failure or cardiac arrest. Carbaryl does not accumulate in mammalian tissue and the cholinesterase inhibition reverses rather rapidly. In non-fatal cases, the illness generally lasts less than 24 hours.

#### FIRST AID TREATMENT

**Following inhalation:** No special measures are necessary. Provide fresh air.

**Following skin contact:** Wash with soap and water.

**Following ingestion:** IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Seek medical attention.

Snails and slugs are active at night, especially when conditions are warm and damp. Sprinkle lightly, snail bait pellets in flower beds and under other dense growing plants and shrubs. Repeat the treatment should fresh infestation appear.

#### Note:

Do not harvest edible crops within 7 days of application.

Store away from food and feeds.

Destroy empty container and never use for any other purpose.
