SYMPTOMS OF POISONING

NOTE TO PHYSICIAN

Treat symptomatically. Treat respiratory difficulty with artificial respiration and oxygen. Do not give morphine, aminophylline, phenothiazines, reserpine, furosemide, or ethacrynic acid. Drugs like 2 PAM are not effective in poisoning with Carbaryl. THEY SHOULD NOT BE USED. Treat symptomatically and supportively. Get medical attention immediately.

Please note:

- Withdraw livestock from treated areas during and for a period of 3 days after treatment.

Do not apply more than they will carry in that day. They are most active from 11:00 to sundown, especially from May to August. Repeat 2-4 days later and again 10 days after that in case the harvesting has not stopped. As the brown adults die off, only white nymphs will come up to forage. 2-4 weeks of well-timed applications will probably) destroy the Colonies, altogether. However, spot treatment may have to continue where on large areas the one or another nest has been overlooked. Avoid application during wet weather conditions.
